AFFIDAVIT - SELF CERTIFICATION OF INSTALLATION OF SMOKE ALARMS AND CARBON MONOXIDE ALARMS

Number of smoke alarms installed _____ **Number of carbon monoxide alarms installed** _____

Smoke and carbon monoxide alarms shall be installed in residential occupancies when a building permit is required for alterations, repairs, or additions and when the total cost or calculated valuation exceeds one thousand dollars (\$1,000). This affidavit is required for exterior work where no access to the interior is otherwise required.

References: California Health and Safety Code Section 13113.7; 2022 California Building Code (CBC) Section 907.11, 2022 California Fire Code (CFC) Sections 907.2.11, 1103.8 & 1103.9; and 2022 California Residential Code (CRC) Sections R314 & R315.

* Smoke alarms shall be installed in each bedroom, and outside each separate sleeping area in the immediate vicinity of the bedrooms, and on each additional story of the dwelling, including basements and habitable attics.

* For dwellings or sleeping units containing fuel burning appliances or having attached garages, carbon monoxide (CO) alarms shall be installed outside each separate sleeping areas in the immediate vicinity of the bedrooms, and on each additional story of the dwelling, including basements.

* Smoke & CO alarms are permitted to be solely battery operated where the installation, repairs, or alterations meet any of the following criteria: 1) Does not result in the removal of wall and ceiling finishes. 2) Limited to the outside exterior surfaces of the dwelling, or 3) Plumbing, mechanical, or electrical work which does not result in the removal of interior wall or ceiling finishes exposing the structure.

* Multi-purpose alarms (combination carbon monoxide and smoke alarms) may be used.

* All alarms shall comply with requirements for listing and approval by the Office of the State Fire Marshal.

* Smoke and CO alarms shall be replaced in accordance with manufacturer specifications; no later than 10 years after manufacture date for smoke alarms or manufacture date cannot be determined.

An owner/agent of the above referenced property, I hereby certify that the smoke alarms and carbon monoxide alarms have been installed in accordance with the manufacturer's instructions and in compliance with the code sections referenced above.

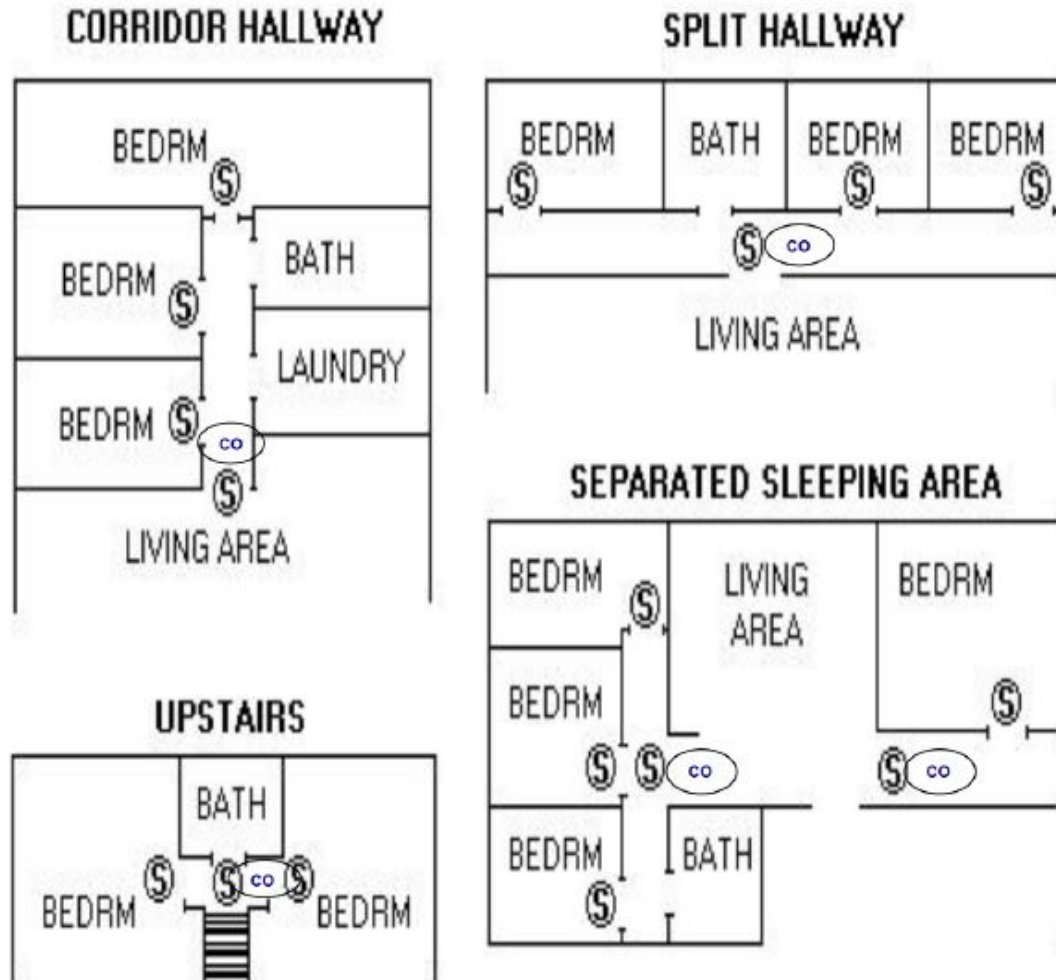
