- ☐ **All work must be performed during regular business hours of Monday-Friday, 7:00 AM to 3:00 PM, NO EXCEPTIONS.**
- ☐ **To notify the DPW Supervisor when the water service is ready for inspection and connection to the public water system, but before any portion of the work is covered. Must be during regular business hours Monday-Friday from 7:00 AM to 3:00 PM.**
- ☐ To replace any street and/or sidewalk that was damaged and to place a \$1,000 bond should a street or sidewalk cut need to be made.
- ☐ To pay, when due, water service charges

**Installation and connection must be inspected and approved before back filling during regular business hours, Monday-Friday from 7:00 AM to 3:00 PM. ALL WORK MUST BE PERFORMED DURING REGULAR BUSINESS HOURS OF MONDAY-FRIDAY, 7:00 AM**



**TO 3:00 PM, NO EXCEPTIONS. Openings into water lines shall be kept closed to storm water during construction.**

**PERMIT FEE IS \$50.00 AND MINIMUM \$250.00 CONNECTION FEE DUE AT TIME OF PERMIT APPROVAL. ANY ADDITIONAL FEES FOR MATERIAL OR SERVICES THAT MAY BE PROVIDED BY VILLAGE OF EDMORE EMPLOYEES ARE DUE AND PAYABLE WITHIN 10 DAYS OF INVOICING. ANY UNPAID BILLS WILL BE ADDED TO PROPERTY TAXES AND BECOME A LIEN ON PROPERTY.**

In consideration of being permitted to make such excavation, I hereby agree that I will faithfully comply with the terms of this permit, including the special provisions, that I will comply with all applicable statutes, rules and regulations of the State of Michigan and the Village of Edmore, that I will indemnify and hold the Village of Edmore harmless from any and all claims, liability loss, damage or expense incurred by the Village of Edmore on account of any injury or death of any person or any damage to property caused by or resulting from activity or work performed under this permit; that I will at all times keep the place where such excavation is made properly guarded by day and lighted by night; that I will leave the street, road, sidewalk, alley or terrace (all require a bond and application for approval) in as good or better condition than existed when the work was commenced, that I will have all finished concrete and asphalt work within the right-of-way performed by a qualified contractor, that all restoration work shall be completed within twenty (20) calendar days of completion; that all restoration work shall be guaranteed for a period of six (6) months from the date of completion; that I agree this permit may be voided by the Village if the work is not started within a reasonable length of time after the above stated starting date.
