TREE REMOVAL PROCEDURES

A permit is to be issued prior to any tree removal, as required in the Land Use and Development Regulations Ordinance at C.348-12. The following are to be submitted for a Tree Removal Permit:

1. Completed application.
2. Check made payable to Toms River Township for \$75.00 (if cash - must be exact change). No fee is required for the removal of dead or dying trees or those requiring removal due to storm damage.
3. Submit photos of all trees.
4. Please note that for removal of ten or more trees, the application may be referred to the Township Forester for review and approval, which normally takes 7 to 10 days.
