6. Shall remove all Underground Service Alert (USA) markings per fee schedule below.
7. It is expressly understood and agreed between the parties to this permit that this is an agreement and permit for access to and for certain events to occur or work to take place on City of Fountain Valley property. This agreement and permit are not a construction contract or an agreement for design professional services as those terms are Defined or used under Title 12 of the California Civil Code.

Permittee shall indemnify, defend, and hold harmless City of Fountain Valley, its officers, employees, and agents from any and all losses, costs, expenses, claims, liabilities, actions, and/or damages, including liability for injuries to any person or persons or damages to property arising at any time during and/or arising out of or in any way connected with Permittee's activities under the terms of this permit unless solely caused by the gross negligence or willful misconduct of City or City's officers, employees, or agents.

A minimum of FORTY-EIGHT (48) HOURS ADVANCE NOTICE must be given to the Public Works Inspector prior to any phase of work for FRIDAYS AND/OR WEEKEND work. Additional encroachment permit fees will be applied.** A copy of this permit shall be kept at the project site at all times while work is in progress. This permit is valid for one year from date of issue. Lane closures are limited to the hours between 8:30 a.m. and 4:00 p.m. Monday thru Thursday, except holidays. **(Please allow up to 8 to 10 weeks for your refund)** IMPORTANT NOTICE: Section 4216/4217 of the Government Code requires a DigAlert identification number be issued before a "Permit to Excavate" will be valid. For your DigAlert I.D. Number, call Underground Service Alert at 1-800-422-4133 two working days prior to work.
