BACKYARD CHICKEN ZONING PERMIT APPLICATION CHECKLIST

Please initial all items on list before submitting permit.

_____ I have read the Johnsonburg Borough Code Chapter 130 and understand the requirements for keeping chickens.

_____ I am aware that I must first apply and RECEIVE APPROVAL from Johnsonburg Borough prior to obtaining chickens.

_____ I will follow all county, municipal, and state laws relating to the care of and keeping animals.

_____ I am aware that I am responsible for always keeping chickens within the confines of my property.

_____ I understand that I may not make any dimensional changes (affecting property setbacks or minimum space requirements) to my chicken coop without first obtaining approval from the Johnsonburg Borough office.

_____ I understand that the maximum number of chickens allowed in relation to my parcel size is detailed in the Johnsonburg Borough Code Chapter 130 and agree not to exceed allowable number of chickens as listed on this application.

_____ I understand that the permit is not transferable from one individual to another or location to another.

_____ I understand that the keeping and handling of chickens may cause health hazards and that adequate health precautions are the responsibility of the applicant.

_____ I understand that private restrictions (deed agreements, rental agreements, etc) on the use of the property shall remain enforceable and shall supersede the permit. A permit issued to a person whose property is subject to private restrictions that prohibit keeping chickens is void.

_____ I am aware that the ordinance allowing chickens may be amended or repealed and that the owner acquires no vested rights to have or raise chickens by virtue of the issuance of the permit.

_____ I am aware that the Johnsonburg Borough Code Enforcement Officer and staff have the authority to inspect property within the borough to ensure compliance and investigate complaints.
