NOTICE : ONCE A BUILDING PERMIT IS PROCESSED NO REFUNDS SHALL BE GIVEN

A Building permit can take up to 20 days to be issued if located within the Adirondack Park, their approval is required first.

Once your building permit has been issued it is your responsibility to call for all inspections associated with your type of permit and this office requires a 72 hour notice for all inspections.

When completing this permit please have a copy of your deed attached to the permit application.

The minimum size building lot in the Town of Broadalbin is one (1) acre, the minimum width size is 150 feet, with the setbacks off of the adjacent property line is 20 feet.

All building projects over 1500 square feet or more than \$20,000 in value, require architectural stamped plans.

If your mobile home is more than ten (10) years old, of the current date, it will be required to have written documentation from an individual or agency such as a Professional Engineer stating that the home is free of heating and electrical system hazards and structurally sound.

A floor plan of the mobile home is required when filing for a permit along with a plot plan of the property unless you are in a mobile home park.

When a parcel has two or more mobile homes on the same property it is considered to be a Mobile Home Park by the Town of Broadalbin and is therefore subject to certain rules.

Current Deed for all new construction

Sufficient plans, drawing, and specifications, including manufacturers installation instructions for such items as wood stoves and central heating units, to determine that the work performed will comply with the State Code and Local Laws.

All plans must be stamped with the seal of an Architect or Professional Engineer.

Certificates of Insurance from Contractors

1. Liability standard form
2. Workers Compensation: state requires C-105.2
3. Disability: State requires DB-120.1
4. If you are not required to carry compensations and disability insurance because you have no employees and have no subcontractors you may fill out a C105.2 instead.
5. Homeowners doing the work themselves need to fill out a BP-1 and C105.21
