REQUIRED DOCUMENTATION FOR SIGN PERMIT APPROVAL

Provide 8 ½" x 11" minimum sized copies of the information listed below. Failure to provide adequate information may result in a delay in the application approval.

1. Sign plan that includes a drawing of the sign features, dimensions, lettering style, background, sign frame, structural support, and type of lighting fixture for illumination.
2. A scale drawing of the area or lot in which the sign will be located, including building elevation for wall signs (photo of building acceptable; GIS printout of parcel acceptable)
3. Drawing or digital photo of proposed sign with dimensions.
4. One (1) color rendering of the sign (digital photo or drawing acceptable)
5. Means of support and materials proposed for use
6. Information to be placed on face of sign
7. Lettering style and font name

ADDITIONAL REQUIREMENTS FOR WALL SIGNS OR PROJECTING OR AWNING SIGNS

- Photo of building façade(s) on which the sign is to be located showing windows, doors, architectural features and dimensions
- Location of all existing and proposed signs on building façade

ADDITIONAL REQUIREMENTS FOR GROUND SIGNS

- Location of the sign on the site (sign cannot be placed in public right of way or sight triangle)
- Type of support

INSTRUCTIONS FOR PLOT PLAN FOR GROUND SIGNS

- All property lines with dimensions
- Existing or proposed buildings with dimensions
- Location and dimensions of driveways and sidewalks
- Location of all existing signs including ground, wall, or projecting
- Location of all proposed signs covered in application
