Application for Seasonal Boat Dock Space is available at the Town Clerk's Office for in person assistance or may be printed from the website and mailed or delivered to the Town Clerk's Office. The Application must be completed and submitted in order to have your name placed on the waiting list for the next available space. The current cost for the seasonal slip is Sixty-five (\$65.00) Dollars per foot.

The Facilities Manager will instruct when a slip is available to accommodate your size boat and an offer along with paperwork and instructions will be sent to you.
