The Releaser HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE during the period the Dumpster is used and placed on a public street.

Chapter 162-2

C. Any Waste Management Company that supplies dumpsters to clients within Charleroi Borough shall, before issuance and delivery of any dumpster on a Borough street or alley, first confirm a dumpster permit was issued from the Code Enforcement office. Dumpsters being placed onto private property are excluded and do not require a permit.

1. Unless otherwise specified on permit in writing, the following shall not be permitted on any Borough street or alley:
 - a. no dumpster larger than 20 feet long x 8 feet wide (must fit within one parking stall and in no way impede traffic lanes) shall be permitted to be placed on any street or alley within the Borough
 - b. dumpster must be placed no less than 30 feet or the equivalence of one parking stall plus 15 feet, whichever is greater, from any intersection
 - c. Dumpster may not be placed along a yellow curb
 - d. Dumpster may not be placed in a handicap accessible parking stall
 - e. Dumpster may not be placed in a traffic thru-way, including sidewalks
