My name is Dave Hails, and I am qualified to fill this seat because I understand the things effecting Exeter through the following;

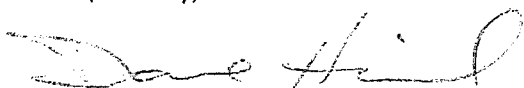

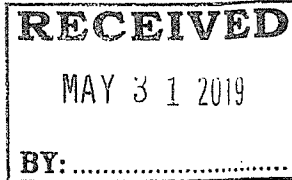

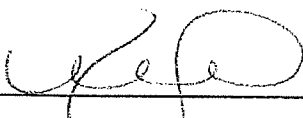
