Set up, maintenance, and removal of handicapped signs and curb painting will be the responsibility of Anaconda-Deer Lodge County after proper installation by the ADLC Road Department. Handicapped Parking Permits are only valid for two (2) years from the date of issuance and renewal. Handicap Parking Permits will not be granted on a temporary basis. These permits will only be issued for individuals who have a current driver's license and currently own and operate a personal vehicle and who have accessed handicapped status through their physician, as proved by the possession of a Handicap Placard from the State of Montana. The issuance of a Handicapped Parking Permit does not constitute a private parking spot for the property owner. Any person with a current and valid handicapped parking placard or handicapped license plates may park in a designated Handicapped Parking Space, regardless of location.
