

**PROCEDURE FOR OBTAINING
A
FUEL STORAGE TANK PERMIT**

1. Complete the attached APPLICATION FOR FUEL STORAGE TANK (S) PERMIT.
2. The application must be signed by the owner of the land and notarized. Agents doing business for the owner will also be required to sign the application form. Notary Publics are available at the Town of Plattsburgh offices for your convenience.
3. Attach a plot plan showing **IN DETAIL AND TO SCALE** the full dimensions of the lot, locating the tanks, lot lines, existing buildings and other important factors on the land.
4. Tank location will be shown in detail by actual location to scale showing all separations between tanks, other fuel containers on the property and containment areas for fuel spillage.
5. Above ground tanks will show protection from vehicle traffic.
6. Buried tanks will show the depth and method of burial with full indications as to material above and below tanks.
7. A full schedule of piping will be included as to the type of piping noting such things as swing joints and venting fixtures between plastic and metal.
8. Foundations and/or cement pads will show the thickness and reinforcement (if applicable) in detail.
9. All electrical work will be detailed and shown on a separate drawing.
10. A listing of the tank by manufacturer and a brief description of the tank, i.e., single walled, double walled, fiberglass tank and whether the tank has been listed by an approved agency such as UL.
11. Any other details such as pumps and extinguishing systems should also be included in a scaled drawing.
12. Deliver completed form, with appropriate fee, to the Town of Plattsburgh Code Office.
13. When all requirements are met, a permit will be issued by the Code Enforcement Officer. There may be a delay if the application requires review by the Town Board and Town Planning Board.
14. **IF THE APPLICATION IS NOT COMPLETE, NO PERMIT WILL BE ISSUED.**

These regulations are a protection, not only for you, but all residents of the area in the Town of Plattsburgh. We thank you for your cooperation and invite you to take part in all our Town meetings.
