Fire Safety Permit Application

(Updated 5/20/25)

THE UNIFORM FIRE CODE:

"It shall be unlawful to engage in any business activity involving the handling, storage, or use of hazardous substances, materials, or devices; to maintain, store, or handle materials; to conduct processes which produce conditions hazardous to life or property; to install equipment used in connection with such activities; or to establish a place of assembly without first obtaining a permit from the fire official. (NJAC 5:18-2.7 9a)

NOTE: Each individual act requires a separate permit. There are five (5) types of permits. You should consult your Fire Official for the number and types of permits required.

Type 1 Permit: \$54.00 Type 2 Permit: \$214.00 Type 3 Permit: \$427.00 Type 4 Permit: \$641.00

Exception: There shall be no fee for Type 4 permits for storage or activity at a premises registered as a life hazard use in accordance with this subchapter.
