SIGN PERMIT APPLICATION PROCEDURE

- **STEP 1: APPLICATION FEE**
 - Application is available online and at Town Hall.
 - The fees for the sign permit application are listed below, and is due prior to issuance of permit:
 - Flush-Mount (Wall) Sign \$50.00
 - Freestanding (Ground) Sign \$75.00
 - Temporary Sign/Banner \$35.00
- **STEP 2: APPLICATION & SITE PLAN SUBMITTAL**
 - Application must be completed and submitted with elevation(s) and site plan (if applicable) to the Planning Department for review to assure the proposed sign(s) conform to all applicable ordinances.
 - Application, elevation(s), and site plan can be submitted to permits@townofnashvillenc.gov.
 - Incomplete applications **WILL NOT** be processed.
- **STEP 3: PLANNING STAFF REVIEW**
 - The following information and exhibits are required to accept and process this application:
 - Complete "Project Information" section of the sign permit application;
 - Site plan of property for new signs (or photo(s) for face replacements) with each sign location identified;
 - Sign plan (drawing) for the specific type of sign you desire. The sign plan must include information on the color, lettering, sign frame, and structural support.
- **STEP 4: APPROVAL AND PAYMENT**
 - Once sign permit application is approved, applicant is responsible for making the appropriate payment.
 - Sign permit is signed by both applicant and Planning Staff.
 - Planning staff will make appropriate copies of the approved sign permit packet for the applicant to submit to Nash County Planning & Inspections Department.
- **STEP 5: NASH COUNTY PLANNING & INSPECTIONS DEPARTMENT**
 - Construction and electrical permits must be secured through the Nash County Inspections Office:
