FENCE REGULATIONS

1. Permit & final inspection required. Cost is \$25.00. Valid for (1) year.
2. Must provide code officer with sketch with proposed location and proposed material to be used.
3. Setback is 6 inches in side and back yards. Any fence erected in a front yard shall be placed at least one foot back from the sidewalk, but in no event may it be less than one foot back from the front line and/or property line.
4. No fence over six feet in height shall be erected or maintained in any rear yard or side yard. No fence over four feet in height shall be erected or maintained in the front yard considered to be the architectural front yard. No fence over five feet in height shall be erected or maintained in the front yard not considered to be the architectural front yard.
5. No fence shall be erected in a front yard in a residential district or along a public right-of-way unless the fence is uniformly less than 50% solid.
6. In any residence district, on a corner lot, no structure or obstruction more than four feet high, measured from the established elevation of the center line of the street nearest to it, which will materially obscure or obstruct the vision of a person using adjoining streets or highways shall be maintained on or along the street lines within a distance of 25 feet of the point of intersection of street lines of the lot.
7. Any fence, wood, stockade, chain link or other type of fence shall have the smooth side or finished side facing to the outside of the property owner installing the fence. Fence posts will be placed on the inside of the fence.
8. Applicant must be able to locate property corners.
