



## Universal Recreational Vehicle (RV) Application

THIS APPLICATION ACHIEVES TWO PURPOSES: 1. ALLOWS A RESIDENTIAL PROPERTY OWNER TO LAWFULLY **STORE** AN RV ON THEIR PROPERTY FOR AN EXTENDED PERIOD OF TIME, OR 2. ALLOWS A RESIDENTIAL PROPERTY OWNER TO LAWFULLY **UTILIZE** THEIR PRIVATELY OWNED OR GUEST-OWNED RV FOR A SPECIFIC PERIOD OF TIME. PLEASE CHECK THE APPROPRIATE BOX BELOW. A DETAILED DESCRIPTION OF HOW TO LAWFULLY **STORE** AND/OR **UTILIZE** AN RV IN GRANITE SHOALS CAN BE FOUND IN THE CODE OF ORDINANCES 40-30 (Ordinance 765-A adopted 7/14/20).

**Note:** RVs **are not** allowed to be stored and/or used in a front yard or driveway except for waterfront properties.

## RV Application (Continued)

\_\_\_\_\_ Under no circumstances shall an RV be allowed to be stored and/or used on or where the RV extends into a public roadway.

\_\_\_\_\_ Waterfront properties and/or corner lots: Under no circumstances shall an RV be stored and/or used as to impair the visibility while egressing private property or traversing an intersection.

\_\_\_\_\_ Under no circumstances shall an RV being lawfully stored on residential property be utilized as a storage container/facility for items such as furniture, tools, or other voluminous items.

\_\_\_\_\_ As called for by the RV manufacture specifications, the RV will only be plugged into the appropriate amperage electrical supply, 30 or 50 amps. (please circle one)
