For the purpose of this section , a new day shall be deemed to be in effect if any auction is conducted at any time within the next 24 hours following the conclusion of any one-day auction sale; provided that if an auction is personally conducted by the owner of the goods being auctioned, at a site owned or rented by him, no fee for the license shall be paid, but a license shall be obtained; and provided further that in no event shall any license be issued for more than 30 days for such purpose.

The fees shall be due with the completed application.

CASH BOND REQUIREMENTS

Each applicant for a license for a TRAVELING SHOW, EXHIBITION GROUND, CARNIVAL, OR CIRCUS shall deposit with the Township Clerk at the time of filing application a cash bond in the amount of \$1,000.00 to guarantee that upon the expiration of the license, the licensed premises will be left in good condition, cleaned up and cleared of all paper, waste material and debris.
