The Johnsonburg Borough's Commercial Film & Photography Permit Ordinance is designed to provide effective coordination of commercial productions that are conducted within the Johnsonburg Borough. When reviewing the ordinance and filling out the permit application for your production, please note the following:

- The application for a Commercial Film & Photography Permit must be submitted no later than 45 calendar days prior to the first day of the production.
- The permit fee is \$100.
- The borough will request reimbursement for certain costs for services provided by the Johnsonburg Police Department, public works department, or any other costs associated with your production.
- Arrangements for filming, videotaping, or photography should not be finalized until such time as you have received a permit. No such production can take place without a permit.
- According to the ordinance, applicants shall provide proof of commercial general liability insurance in an amount not less than \$1,000,000 per occurrence and \$2,000,000 aggregate and name the Johnsonburg Borough as an additional insured where required by the borough.
- Adjoining property owners/neighbors must be notified at least two weeks in advance of the scope and timetable of your production. The borough office must be copied on this communication. Please email this letter to office@johnsonburgpa.com.
