Dear Customer:

Enclosed is a cross-connection survey that is required to be sent out every two years.

The purpose of the survey is to protect the water supply from cross-connection contamination from customer's plumbing systems. The information you give in the survey is very important to determine where possible cross-connections exist within our water supply.

A cross-connection is defined as any connection in which a drinking water service line is connected to a device containing water of unknown quality. Examples of cross-connections include but are not limited to hot water heating systems, sprinkler systems, chemical mixing tanks, cooling towers, soda fountains, swimming pools, various dental office equipment, and various medical clinic equipment.

The following is an example of how a water supply can be contaminated by a cross-connection.

A customer has a drinking water service line connected to a hot water heating system that contains rust inhibitor (chemical). There is a water main break in close proximity to that customer's service line. The water main break creates a drop in pressure that, in turn, allows chemical from the customers hot water heating system to feed back into the water system resulting in contamination of the water system.

It is imperative that you fill out the survey and return it by May 30, 2025, to: Noble Village Hall, P.O. Box 278, Noble, Illinois, 62868. You can also drop it off at the Noble Village Hall office or put it in the drop box at the Noble Village Hall.
