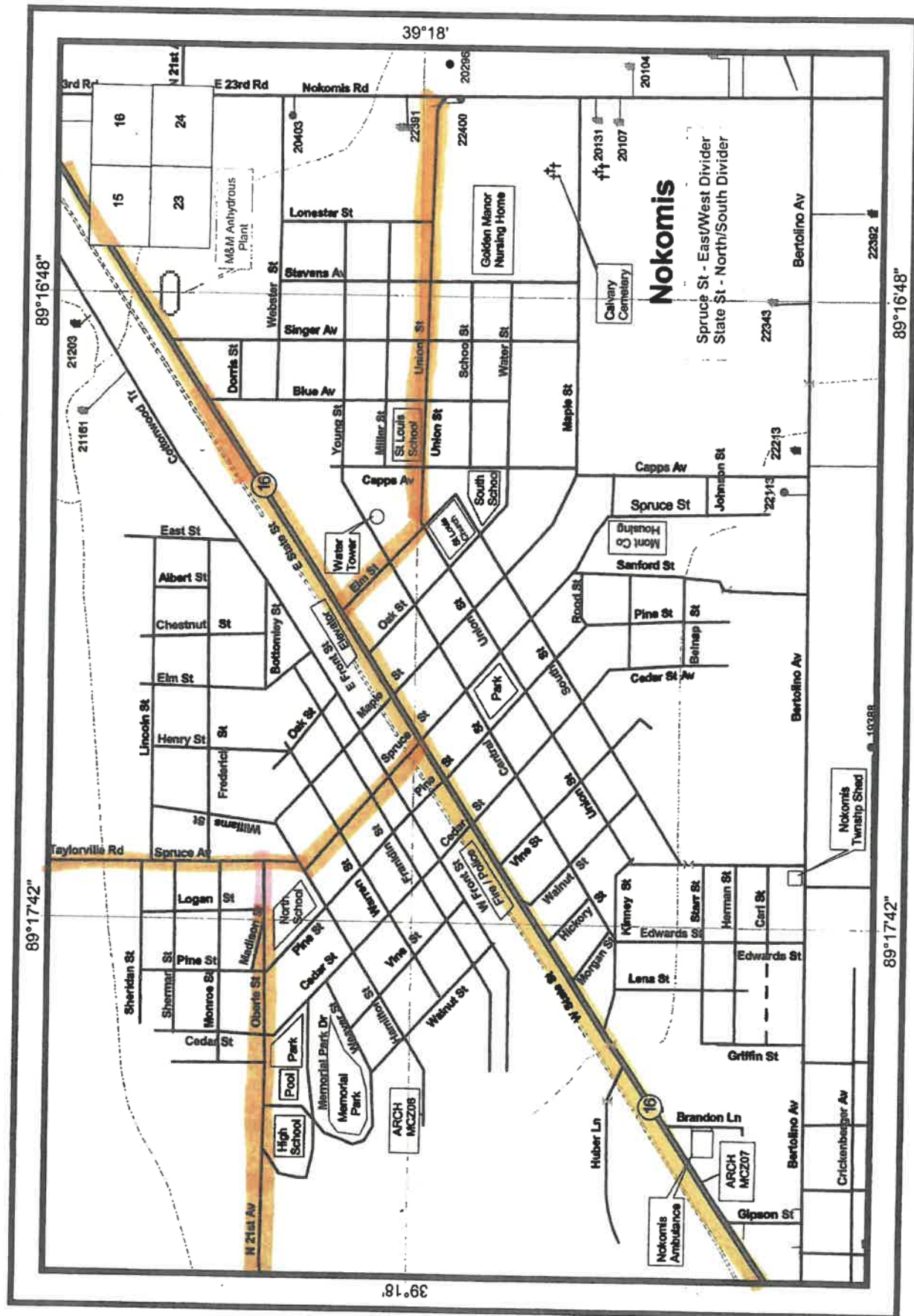

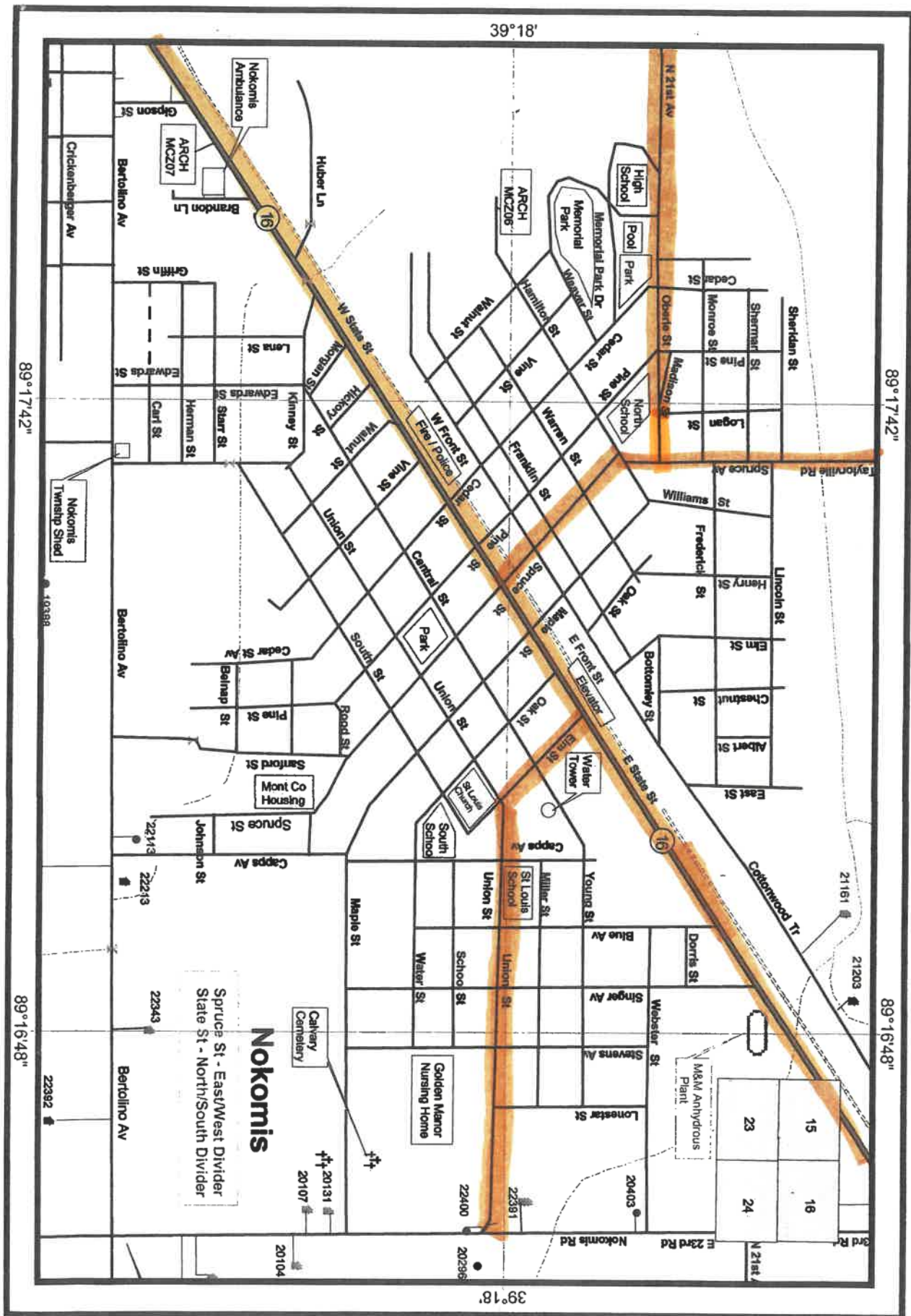

Ordinance No. 2142

**AN ORDINANCE AMENDING SECTION 24-8-5 OF THE REVISED CODE OF
ORDINANCES OF THE CITY OF NOKOMIS, ILLINOIS REGARDING OPERATION
OF NON-HIGHWAY VEHICLES WITHIN THE CITY**

WHEREAS, the City of Nokomis, Illinois (hereinafter, the "City") is an Illinois non-home rule municipal corporation pursuant to Article VII, § 7 of the 1970 Illinois Constitution, organized and operating under the Illinois Municipal Code (65 ILCS 5/1-1-1, *et seq.*); and

WHEREAS, Section 11-1426.1(d) of the Illinois Motor Vehicle Code (625 ILCS 5/11-1426.1(d)) grants municipalities the power to authorize the use of "non-highway vehicles" on its roadways upon a determination, after considering "the volume, speed, and character of traffic on the roadway and determine whether non-highway vehicles may safely travel on or cross the roadway", that the public safety will not be jeopardized; and

WHEREAS, pursuant to the foregoing authority, the City has heretofore adopted Ordinance No. 2028 on June 27, 2016, which was thereafter codified in Article VIII, Chapter 24 of the Revised Code of Ordinances of Nokomis, Illinois (hereinafter, the "Code"); and

WHEREAS, the corporate authorities of the City have determined that additional intersections within the City should be designated as permitted crossings for non-highway vehicles, as stated herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOKOMIS, MONTGOMERY COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The recitals contained above in the preamble of this Ordinance are hereby incorporated herein by reference, the same as if set forth in this Section of this Ordinance verbatim, as findings of the Mayor and City Council of the City of Nokomis, Illinois.

SECTION 2: Section 24-8-5 of the Code is hereby amended to read as follows, with italicized portions to be added:

24-8-5 PROHIBITED STREETS. Permitted vehicles shall not be permitted on the following state or county streets, but may

cross perpendicular to these streets as permitted by Illinois Statute:

- (A) State Street (Route 16);
- (B) North Spruce Street;
- (C) Oberle Street;
- (D) South Elm Street *between State Street (Route 16) and East Union Street*;
- (E) East Union Street *between South Elm Street and Nokomis Road (County Road 2300 E)*; and
- (F) Madison Street between Logan Street and North Spruce Avenue.

SECTION 3: If any section, paragraph, or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, or provision shall not affect any of the remaining provisions of this Ordinance, which are hereby declared to be separable.

SECTION 4: This Ordinance is effective upon its passage, approval, and publication as required by law.

SECTION 5: The Mayor is authorized and directed to sign and the City Clerk is authorized and directed to attest to this Ordinance.

SECTION 6: The City Clerk shall publish this Ordinance in pamphlet form and shall see to its inclusion in the next published update of the Code.
