



Application for Parade Permit Instructions

Dublin Police Services requires all parades and events under the Dublin Municipal Code (DMC) Chapter 5.12 to be registered and obtain a permit from the Chief of Police. The purpose of this chapter is to regulate parades occurring on, upon, or along any city street, sidewalk, alley, or other public way to ensure the safety of parade participants and observers, promote the free flow of vehicular and pedestrian traffic and facilitate multiple uses of such property. (Ord 6-08 § 2 (part))

Application Fee. All applications shall be submitted with payment of a non-refundable fee pursuant to resolution of the City Council. (Ord 6-08 § 2 (part))

The guideline and process for obtaining a permit can be found in Dublin Municipal Code (DMC) Chapter 5.12.

To ensure a complete application, please include the following documents:

- ☐ Completed Application for Parade Permit
- ☐ Copy of Parade Route Map
- ☐ Copy of written permission by property owner (as applicable)
- ☐ Non-refundable application fee of \$130.00. Fees may be paid via cash, credit card or check. Applications submitted without fee shall be deemed incomplete unless a waiver is submitted.
- ☐ Proof of general Liability Insurance and Automobile Insurance (if applicable) per DMC 5.12.110.
- ☐ Service Charges. This parade/event may be subject to service charges per DMC 5.12.110.
