**KNOW ALL PERSONS BY THESE  
PRESENTS:**

THAT we, \_\_\_\_\_ as Principal, and \_\_\_\_\_ a corporation organized under the laws of the State of \_\_\_\_\_, and authorized to transact surety business in the State of Washington (hereinafter called the "Surety"), are held and firmly bound unto the City of Puyallup (City), a Political Subdivision of the State of Washington, as Obligee, in the full and just sum of \$ \_\_\_\_\_ dollars ( \_\_\_\_\_ ) (which sum shall be designated by the city engineer but may not be less than \$5,000 or 10% of the estimated construction cost, whichever is greater) to the payment of which well and truly to be made we do bind ourselves, successors and assigns, firmly by these presents.

WHEREAS, the above named Principal has constructed and installed certain improvements in connection with a project as described in the above referenced permit and within the City at \_\_\_\_\_ (site address), which project required the construction of a stormwater facility or improvement in the City of Puyallup; and

WHEREAS, said Obligee requires that a good and sufficient bond be furnished by said Principal guaranteeing against all defects in workmanship and materials for the stormwater facility or improvement for the period of twelve (12) months after completion and approval of project construction to the City of Puyallup.

NOW, THEREFORE, the condition of this obligation is such, that if within twelve (12) months from the date of completion of construction of said project permit there shall be disclosed poor workmanship in the execution of said work, and the carrying out of the terms of said permit, or it shall appear that defective materials were furnished thereunder, then this obligation shall remain in full force and effect, otherwise this instrument shall be void. If the city identifies any repair work the financial guarantee will extend to an additional twelve (12) months after the repair is accepted by the city.

This bond may not be cancelled or allowed to expire by the Surety for any reason during the period in which it is required to be in effect under the terms of the permit and applicable City ordinances, except upon not less than thirty (30) days' prior written notice to the City of Puyallup, delivered by certified mail. Such cancellation or expiration shall not affect any liability incurred or accrued under this bond prior to the effective date of cancellation or expiration. This bond shall remain in full force and effect until released in writing by the City of Puyallup, regardless of the payment of premiums or any other act or omission of the Principal or Surety, and shall not be subject to termination, cancellation, or expiration except as provided herein.
