Title V, Chapter 110, Sec. 5.110.3200. Licenses not transferable or assignable; exception; change of ownership or control. (a) No license issued under this chapter shall be transferable or assignable except as follows: (1) In the event of the death or an individual licensee, the widow, widower, or next of kin of such deceased licensee, may make written application to the officer for transfer of such license to permit the use of the license for the remainder of the license year for which the license fee has been paid. The new applicant must meet all the requirements under this chapter and state law for the issuance of a new license. (2) Whenever one or more members of a partnership license leaves the partnership, for whatever reason, the remaining partner(s) originally licensed may apply to the officer to continue to use the license for the period for which the license fee has been paid. (b) No licensee under this chapter shall make any change in its ownership, management or control without first filing with the officer a notice in writing of the licensee's intention to do so, along with an affidavit listing the name and address of the new ownership, management or control. If the proposed change is of the managing officer of the licensee, the officer, upon determination that the proposed new managing officer meets the requirements of this chapter, may approve such change. (c) The officer is authorized to establish regulations to implement the authority granted herein to approve changes and transfers made pursuant to this subsection.
