\* CALHOUN COUNTY IS IN THE COASTAL TIER OF COUNTIES REQUIRING ADHERANCE TO WINDSTORM CONSTRUCTION CODES. THE CITY'S BUILDING CODE REFLECTS AMENDMENTS TO THE IBC/IRC 2006 ISSUED BY THE TEXAS DEPARTMENT OF INSURANCE (TDI) REGARDING WINDSTORM CERTIFICATION. CERTIFICATION BEGINS VIA AN APPLICATION FOR CERTIFICATION BY THE ISSUANCE OF A WPI-1 FROM TDI AFTER A LICENSED WINDSTORM INSPECTOR COMPLETES THE PRELIMINARY FORMS BEFORE CONSTRUCTION BEGINS. ON COMPLETION OF CONSTRUCTION AND FINAL INSPECTION, AND IF PASSED, A WPI-8 WILL BE ISSUED. **THERE IS NO REQUIREMENT, BY THE CITY, THAT WINDSTORM INSURANCE BE OBTAINED BY ANYONE, HOWEVER, LENDERS AND MORTGAGE HOLDERS, IN ALMOST ALL CASES, WILL REQUIRE WINDSTORM INSURANCE.** THE ONLY WAY TO OBTAIN THIS WINDSTORM INSURANCE IN THE COASTAL TIER OF COUNTIES IS WITH A VALID WPI-8 CERTIFICATE.

\* MANUFACTURED HOUSING HAS SLIGHTLY DIFFERENT CRITERIA, WITH THE FINAL CERTIFICATE ISSUED AS MH-8.
