SIGNS: TWO SIGNS ONLY – ONE ON THE PROPERTY OF THE SALE AND ONE AT ONE INTERSECTION. SIGNS MAY NOT BE PLACED ON TELEPHONE POLES OR IN THE RIGHT-OF-WAY. SIGNS MUST BE AT LEAST 10 FEET FROM THE CURB LINE OF THE STREET.

THE SIGNS MUST BE REMOVED WITHIN TWENTY-FOUR (24) HOURS OF THE SALE'S CONCLUSION.

You are permitted to have one garage sale per year in addition to participating in the Town-Wide garage sale in June.

Your garage sale license must be prominently displayed on premises upon which the garage sale is to be conducted throughout the entire period of the licensed sale.

ALL GARAGE SALES SHALL BE CONDUCTED BETWEEN THE HOURS OF 8:00 A.M. AND 8:00 P.M. ONLY.

TWO SIGNS ONLY !!!

AND ONE AT ONE INTERSECTION.**

**SIGNS MAY NOT BE PLACED ON
TELEPHONE POLES OR IN THE RIGHT-OF-

**THE SIGNS MUST BE REMOVED WITHIN
