AGREEMENT:

I, the undersigned applicant for a travelway permit within the City of Goliad as described above do hereby understand and agree that should this application for a travelway permit be approved, it is subject to the following covenants and conditions:

1. The approval of this travelway permit application and the issuance by the City of Goliad and of any related rights, shall not constitute an abandonment by the City of any rights of any nature in the right-of-way described above.
2. The permittee (and heirs, successors, and assigns) agrees to hold harmless, defend and indemnify the City from and against any and all claims arising in relation to the above mentioned placement of travelway on city property.
3. The permittee agrees that his or her use of the right-of-way area is subject to the superior right of the City utility and roadway systems and any public utility company to construct, repair, and maintain utility systems within the right-of-way area. The permittee agrees that he or she will remove the above named travelway from the right-of-way area at his or her own expense within ten (10) days of the date of notice by the City that the travelway interferes with use of the right-of-way area for construction, repair or maintenance of a utility or roadway system. Should an emergency situation arise that would require immediate use of said right-of-way by the City, said City reserves the right to immediately remove the encroachment and Permittee agrees to reimburse City for all costs associated therewith.
4. This permit, until expiration or revocation, shall run with title to the above-described property and shall be binding upon subsequent owners of the property. The permittee and each of his

or her successors in interest shall give actual notice of the terms of this permit to subsequent purchasers of the property.

5. Permittee agrees that all maintenance related to items placed on city right-of-way pursuant to this permit shall be the sole responsibility of permittee.
6. This permit shall expire immediately upon removal of the travelway that is the subject of this permit.
