PLEASE READ THE FOLLOWING CAREFULLY

NOTICE: It is unlawful for any person to engage, directly or indirectly, in a charitable car wash without first obtaining a valid charitable car wash permit pursuant to the provisions of this chapter.

Permit Limitations

The location requirements and limitations for charitable car washes are as follows:

1. May be conducted in a location zoned for commercial uses.
2. May not be conducted on residentially zoned property or at any house, apartment, or other dwelling. The limitation regarding residentially zoned property shall not apply to religious or educational institutions.
3. May not be conducted within three hundred (300) feet from a commercial car wash. The distance shall be measured from property line to property line unless the property on which the car wash is to be held is greater than two (2) acres. In the case of properties greater than two (2) acres, the applicant shall designate an area for operation for approval by the City. Said area shall not be within three hundred (300) feet from a commercial car wash.
4. May not be conducted at any commercial property that has held four (4) prior car washes in the calendar year (excluding licensed commercial car wash locations).
5. May not be conducted within twenty-five feet (25') from the street curb, or from the near edge of the travel lane or lanes of any uncurbed street or road.
6. Permits are only valid for one day.
7. Car washes can only take place between the hours of 8 AM and 6 PM.
8. The applicant must pay an application fee of **\$20.00**. It will be refunded if the Permit Holder reports its earnings within thirty (30) days.
