PLEASE NOTE:

**EVERY PERSON WORKING ON AND/OR DRIVING A
MOBILE CATERING TRUCK IN MAHWAH MUST:**

- 1) HOLD A VALID TOWNSHIP OF MAHWAH SOLICITOR PERMIT**
- 2) BE LISTED ON THE VENDOR'S FOOD LICENSE APPLICATION**

- Contact the Mahwah Police Department, 221 Franklin Turnpike to apply for a Solicitor Permit (\$100 fee per applicant applies).
Background check and approval may take up to four weeks.
- Apply for your Mobile Food Vendor License at the Mahwah Health Department. (Cold Truck \$150, Hot Truck \$250) Application may be made prior to receiving your Solicitor Permit, but your Food license will not be issued until after the Solicitor Permit is approved by Mahwah PD.
- If you are renewing a year-round license, you must make an appointment with the Health Department for a vehicle inspection by January 31st. Truck must be fully stocked for the inspection (NJAC 8:24-9).
- New licensees are not permitted to operate in the Township at all prior to initial inspection.
