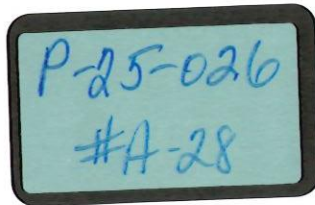

**NOTICE OF PUBLIC HEARING
CITY OF BAYONNE PLANNING BOARD**

PLEASE TAKE NOTICE that the City of Bayonne Planning Board (the "Board") will hold a public hearing on Tuesday, August 11, 2026, at 6:00 p.m. in the Dorothy E. Harrington Council Chambers of Bayonne City Hall, which is located at 630 Avenue C, Bayonne, New Jersey 07002, to review and take formal action on an application for Preliminary and Final Major Site Plan approval, and all other ancillary relief, if required (the "Application") by Kennedy Boulevard MW Urban Renewal LLC & 373 Kennedy Blvd Partners LLC (collectively the "Applicant") with respect to property having a street address of 361-363; 365-371; and 373 JF Kennedy Blvd (also known as John F. Kennedy Boulevard), Bayonne, New Jersey 07002, which is designated as Block 262, Lots 7, 8, & 9 on the City of Bayonne Tax Duplicate (collectively, the "Property"). The Property is subject to a redevelopment plan, which permits mixed-use (multi-family residential and retail/commercial) buildings.

The Applicant seeks Preliminary and Final Major Site Plan approval to construct a six-story mixed-use (multi-family and commercial/retail) building containing: 66 residential units; 71 parking spaces (utilizing garage parking and a mechanical parking system); approximately 663 sq. ft. of retail space; internal loading zone; bike parking; a gym; amenity space; stormwater management improvements; common and private roof decks; green roofs; and various other improvements shown on the filed plans.

The Applicant also seeks any and all deviations, exceptions, design waivers/exceptions, submission waivers, variances, *de minimis* exceptions to the State of New Jersey Residential Site Improvement Standards, interpretations, continuations of any pre-existing non-conforming conditions, modifications of prior imposed conditions, and other approvals reflected on the filed plans (as same may be further amended or revised from time to time without further notice) and as may be determined to be necessary during the review and processing of the Application.

When the Application is called, interested parties may appear at the hearing, either themselves or by attorney, and present any questions, comments, objections, or testimony that they may have to the Application. Interested parties may also retain expert witnesses to present any questions, comments, objections, or testimony regarding the Application. The hearing may be continued without further notice on such additional or other dates as the Board may determine.

At least 10 days before the hearing, the Application and supporting materials (including maps, documents, and plans) will be on file and available for public inspection with the Board and/or the Board's Administrative Officer at the Board Offices located in Bayonne City Hall, 630 Avenue C, Bayonne, New Jersey 07002 during normal business hours. You may also arrange for the inspection of the aforementioned Application and supporting materials by contacting Board Secretary Alicia Losonczy by (a) email at alosonczy@baynj.org or (b) telephone at 201-858-6182 during normal business hours.
