Insurance must remain active for duration of permit. Lapse results in automatic suspension.

*copies of all insurance certificates must accommodate permit and must be updated if term ends during permit time frame.

5. Fees

Annual Food Vendor Permit Fee: \$250.00

Permit is non-transferable and non-refundable.

6. Compliance Requirements

Vendor agrees to comply with:

NYS Department of Health regulations

Delaware County Health Department regulations

NYS Uniform Fire Prevention & Building Code

Village of Walton Local Laws and Ordinances

Fire inspection requirements (if propane, generators, or cooking equipment used)

Waste disposal and grease containment standards

Vendor must provide:

- ☐ Fire extinguisher (minimum ABC rated)
- ☐ Proper food temperature control equipment
- ☐ Handwashing station (if required)
- ☐ Trash receptacles for public use (Carry in, carry out)
- ☐ Proof of propane system inspection (if applicable)

7. Inspections

The Village of Walton Code Enforcement Officer and/or Fire Department may inspect vendor operations at any time during operations.

Failure to pass inspection may result in:

Immediate suspension

Revocation of permit

Civil penalties

Appearance ticket issued under Village Code

8. Revocation Clause

This permit may be revoked by the Village Board for:

Health code violations

Fire safety violations

Non-payment of fees

Operating outside approved location

Repeated complaints or nuisance conditions

False statements on application

Revocation requires majority vote of the Village Board.
