I understand that once I am at the legal limit of animals allowed per the City of Bay City Code of Ordinances that this multi-pet permit will be voided and that I must stay at that legal limit. I shall comply and continue to comply with all provisions of the City of Bay City Animal Control Code of Ordinances for the City of Bay City and all applicable laws of the State of Texas regarding animals. I understand that this permit may be revoked and denied for any reason listed in Section 14-20: (3)(d) after approval. I understand that before this application/renewal can be approved, an Animal Control Officer must inspect the property and must interview occupants of adjacent properties. If this is an application, I understand that I am to pay a one-time application fee of \$25. Photos of animals will be taken at time of inspection.
