The City of North Bonneville charges residents a fee of \$25 for ½ day usage or \$35 for full day usage. Non-residents are charged a fee of \$60 for ½ day usage and \$75 for full day usage.

AM is 6am-2:15pm, PM is 2:15pm-10:30pm. This fee is for, but not limited to: replacement of equipment, clean up, maintenance, labor and/or repair. The deposit will not be refunded if the reservation is canceled.

The fee is charged for use of the gazebo only and not the surrounding park area which is available without charge.

The serving of alcohol will require a liquor license.

Gazebo Rules:

- Use the facility at your own risk
- Be courteous to park visitors
- Keep pets under control (dogs on leash) and pick up after them
- Please keep the gazebo facility and adjoining park areas clean
- Vandalizing the gazebo is a serious offense and will be prosecuted
- Park in designated parking areas (across from basketball court)

Applicant agrees to clean up the gazebo after usage.

Applicant agrees to comply with all City laws and ordinances as they relate to the gazebo's usage.

Applicant understands that there may be health and safety risks associated with use of this facility.

Applicant has read the gazebo rules noted above and agrees to abide by them.

Applicant agrees to call attention of these rules to those parties participating in this event.

Applicant agrees to assume responsibility for their guests' conduct and actions.

Applicant agrees to call any gazebo issues or problems to the City's attention.

The applicant hereby releases, discharges and agrees not to bring claim or suit against the City of North Bonneville for any injury, death or damage to or loss of personal property arising out of, or in connection with use of the gazebo from whatever cause, including the active or passive negligence of the City of North Bonneville or any other participants using the facility and equipment.

I have read this application form and fully understand its contents and agree not to sue or bring claim against the City of North Bonneville for use of this recreational activity. I am aware that by affixing my signature below I am providing a full release of liability from the gazebo's use.
