**EXPLANATION OF
PLUMBING INSPECTION REQUEST FORM**

1. The following conditions shall be considered:

- I. **Newly Constructed Facilities:** All portions and installations of the plumbing system shall be installed by properly licensed and registered Illinois plumbing contractors and inspected by the State of Illinois plumbing inspector.
- II. **Expansion and/or Change of Use of Existing Facilities:** Any building, structure or space whereby its original use is being changed from use group to another, the plumbing will be treated as #I for Newly Constructed Facilities. This includes the renovation or expansion of existing properties that will result in an increased seating capacity and or occupant load in which restrooms or other plumbing fixtures shall be required. All portions and installations of the plumbing system shall be installed by properly licensed and registered Illinois plumbing contractors and inspected by the State of Illinois plumbing inspector.
- III. **Existing Facilities:** In existing buildings, structures or spaces whereby the use group remains the same and no new plumbing work is expected to be involved, the facility shall be inspected/surveyed by state plumbing inspector to determine if additional plumbing shall be required and the results forwarded to the requesting agency for follow up action.
- IV. **Section 890.1910 Inspections**
A plumbing system or any part thereof shall not be enclosed, covered up or used until the system has been inspected and approved by a plumbing inspector. It is the responsibility of the licensed plumber or plumbing contractor on the job to arrange for inspection by the Department or a local plumbing inspector. The plumbing inspector may require tests as listed in Section 890.1930 to determine whether or not the system as installed is in compliance with this Part. Plumbing found not to be in compliance with this Part shall not be approved. A plumbing system not complying with the provisions of this Part shall not be used until such time as it is brought into compliance with this Part. After the plumbing corrections have been made, the plumbing contractor shall arrange for reinspection.
