Please continue to contact us and continue to complete a notification before each burn. Unless otherwise stated on the permit, expiration will occur after 30 days from issuance.

I have read and familiarized myself with provisions of the City of Santa Fe Outdoor Burning Ordinance, also known as Chapter 5, Section 5 "Outdoor Burning" of the Ordinance of the City of Santa Fe, Texas. I understand that all outdoor burning must be conducted in a safe manner and in compliance with this ordinance. I understand that any failure to comply with these regulations, adverse changes in environmental conditions or the creation of a public nuisance, whether intentional or unintentional, will be grounds for a temporary or permanent cancellation of this permit. I understand that any duly authorized agent of the City of Santa Fe or Santa Fe Fire and Rescue may require the extinguishing of any fire allowed by this permit.

Furthermore, I attest that there is no practical alternative to burning and affirm that I will conduct the burning in a manner that will not cause or contribute to a nuisance, traffic hazard or to a violation of any federal or state primary or secondary ambient air standard.
