The Solar Farm will consist of a multi-array, ground-mounted, fixed-tilt photovoltaic solar system with various electrical appurtenances, including transformers, inverters and interconnection equipment. Each array will contain several panels, typically supported by short driven steel posts or drilled pier foundations. Additional infrastructure will include fencing, gravel access roads, swales and stormwater management areas. Generally, only minor cuts and fills will be required to develop this project.

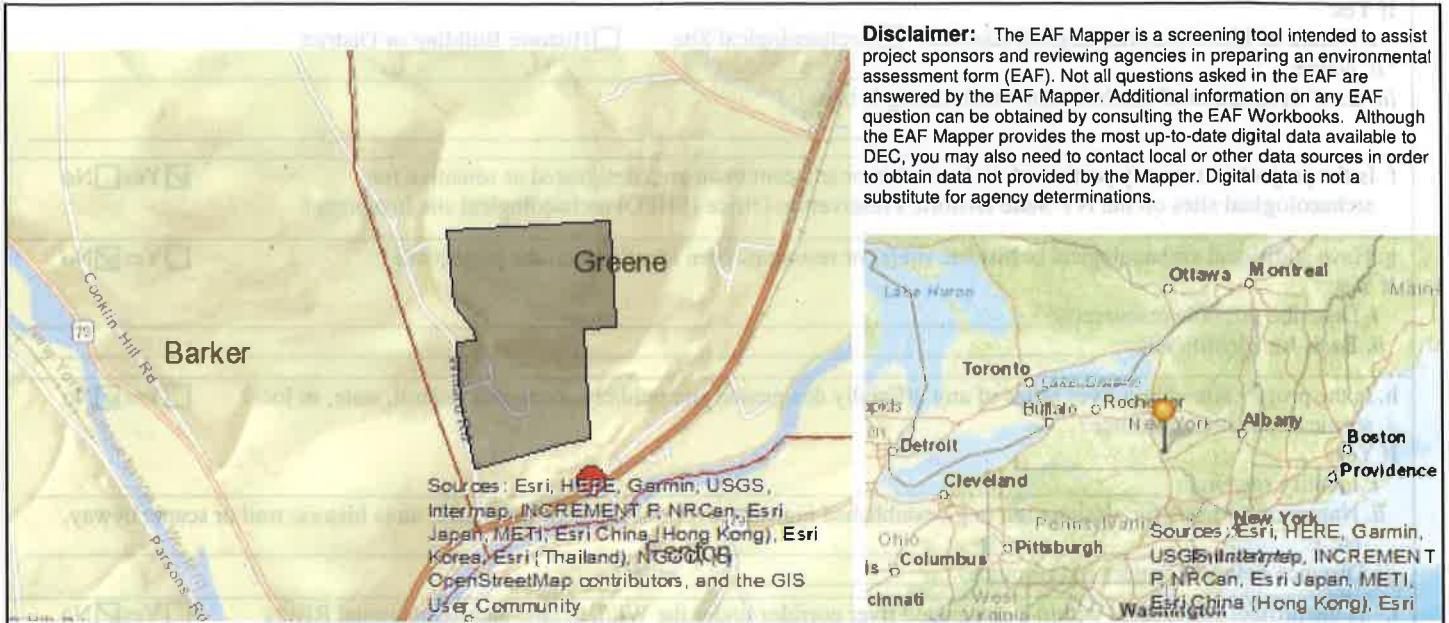
