GUIDELINES FOR PLAY

- Any play must be associated with an online booking only.
- Maximum play time is 1 hour 45 minutes.
- Anyone without a permit may be asked to leave.
- Guest must be accompanied by a permit holder, limit 3 guests per permit holder. Guest fee required per play.
- Pickleball is only permitted on Tennis Courts 4 & 5 and Paddle Courts 1 & 2.

The Village of Bronxville will conduct routine maintenance to the paddle courts which includes clearing of leaves, snow, and ice. Staff will actively monitor conditions and service the courts as quickly as possible. Given the timing of some weather events, the courts may not be clear before your scheduled play. **During severe weather events, the Village reserves the right to shut down play for up to 48 hours.** We appreciate your cooperation and flexibility.
