Dear Taxpayer,

The Tax & Water Office has an ACH bank draft program (direct withdrawal) available to our taxpayers. This service assures your payment will be received in a timely manner as well as providing a safe and secure way to pay your taxes and water.

Quarterly property tax and/or water payments as billed can be debited from your CHECKING or SAVINGS account on the payment due dates of August 1, November 1, February 1, and May 1. We do not draft from equity accounts. You may enroll at any time, **PROVIDED A COMPLETED AUTHORIZATION FORM IS RECEIVED AT LEAST TWO WEEKS PRIOR TO THE SCHEDULED DRAFT DATES.** Cancellation of such transactions shall be in writing and submitted to the Tax and Water Office 30 days in advance of the cancellation.

Please be aware that there will be a \$20.00 fee if an automatic withdrawal is returned due to insufficient funds or the account number given on the application is incorrect.

If you would like to enroll in this program, please complete the entire authorization form enclosed with this letter. Be sure to attach a voided check. Incomplete applications will delay enrollment.
