1. Anyone without a business license and/or permit will be asked to leave the event immediately.
2. Vendors will receive a citation for \$50.
3. Food vendors that are not permitted with Fresno County Environmental Health that are preparing or storing food that poses a hazard to human health will have their food confiscated and destroyed.

- I understand that as a sidewalk vendor, I am required to ensure compliance with the Federal Americans with Disabilities Act of 1990 and other disability access standards
- I understand that as a sidewalk vendor, I may be required to possess a California Department of Tax and Fee Administration Seller's Permit.
- I understand that as a sidewalk vendor, I am required to obtain additional licenses from other state and local agencies to the extent required by law, such as the County Health Department
- I understand that if I am selling on someone else's property, I must have an approval from the property owner
- I understand that if I am selling at Reedley Beach or Cricket Hollow, a fee will be charged at entrance

I understand that it is my responsibility to be in compliance with the requirements of the City of Reedley and any other governmental agencies affecting operation of this business.
