Fees:

There is a nonrefundable fee for reviewing an application for proposed development in the Town of New Haven. The fee for single-family residential properties is \$0.00. The fee for multi-family residential properties is \$75.00/ the fee for commercial properties is \$100.00 plus expenses to cover the cost of layer fees, engineer fees, etc. Payment of the base fee amount shall be required at the time of application. Payment of additional expenses shall be payable upon receipt of an itemized accounting of expenditures for all costs over \$100.00.
