(A) The applicant shall not , , , information contained in the application during the period for which the permit is in effect. A permit will be issued when the application has been determined to be complete and when the proposed work is determined to conform to the requirements of the Uniform Code. The authority conferred by such permit may be limited by conditions, if any, contained therein.

(B) A Building Permit issued pursuant to this Part shall be prominently displayed on the property or premises to which it pertains.

(C) A building permit issued pursuant to this Part may be suspended or revoked if it is determined that the work to which it pertains is not proceeding in conformance with the Uniform Code or with any condition attached to such permit, or if there has been a misrepresentation or falsification of a material fact in connection with the application for the permit.

(D) A building permit issued pursuant to this Part shall expire one (1) year from the date of issuance or upon the issuance of a Certificate of Occupancy/Compliance. The permit may, with permission of the Code Enforcement Official, be renewed for successive one (1) year periods provided that the permit has not been revoked or suspended at the time the application for renewal is made.

(E) Plans and specifications for the proposed work shall be enclosed with this application and those plans and specifications, IF REQUIRED, shall be in accordance with the State Education Law, Sections 7307 and 7209.
