Exemption From Licensing

Arizona Revised Statutes (A.R.S.) 32-1121A.5 is an exemption in the state licensing law that allows residential property owners to: *Do the work themselves* or *Do the work jointly with their own employees* or *Do the work with licensed contractors*.
