- 1. APPLICATION**
- 2. CERTIFICATE OF PUBLIC LIABILITY/PROPERTY DAMAGE INSURANCE
(NOT LESS THAN \$100,000.00 INJURY OR DEATH TO TWO OR MORE
PERSONS RESULTING FROM ANY ACCIDENT)**
- 3. STATEMENT – INSURANCE CO. WHEN POLICY/POLICIES ARE CANCELLED
(AT LEASE 30 DAYS BEFORE THE LIABILITY OF THE INSURER EXPIRES)**
- 4. STATEMENT – LIST OF ALL CLAIMS, SUITS OR ACTIONS PENDING AGAINST
APPLICANT FOR PERSONAL INJURIES OR PROPERTY DAMAGE &
AMOUNT OF CLAIM AND STATUS**
- 5. BOND - \$10,000 INDEMNITY BOND**
- 6. \$150.00 FEE – DUE OCTOBER 1 OF EACH YEAR (MAY BE PRORATED)
EXPIRES AT MIDNIGHT ON SEPTEMBER 30 OF EACH YEAR**
- 7. EACH VEHICLE OPERATED UNDER THIS PERMIT SHALL DISPLAY THE
COMPANY NAME, PERMIT NUMBER, AND CURRENT TELEPHONE NUMBER
OF THE COMPANY.**
