## **General Building Regulations**

### **(Electrical)**

To ensure safe, quality workmanship the Town of Edgecliff enforces the 1999 Electrical Code.

Permits are required for new construction, additions, alterations or repairs, both residential and commercial.

Electricians must be registered to perform work in the Village. A registration fee of \$150.00 must be paid before the issuance of a permit if not already registered. Registration is valid for one year from date of issuance. The master is responsible for registration and obtaining permit.

Inspections require twenty-four hour notification prior to the day of the inspection. Inspections will be made in the morning between 8:00 and 12:00 or the afternoon between 1:00 and 5:00. Contractors may request either a.m. or p.m., no special appointment times will be accepted. The phone number to call to schedule an inspection (817) 293-4313.

#### **Electrical Inspections**

**Temporary Pole or Saw Pole** - Inspection of temporary pole prior to release for services to TXU.

**Electric cover or Rough** - Wiring, boxes and conduit installed.

**Electric Ceiling Cover (Commercial)** - Inspection of above ceiling wiring, boxes and light fixtures.

**Underground (URD)** - Inspection of conduit or direct burial cable to ensure proper burial depth and material used.

**M.L.&S. or Meter Loop & Service** - Inspection of grounding and wiring to ensure safety prior to releasing to TXU for permanent service.

**Reconnect or Name Change** - Change of ownership, repair or rewire of existing service.

**Final** - Inspection of entire electrical system.
