The undersigned understands and agrees to the following conditions:

1. To **establish service** complete and submit this application to FORU in person, mail, or [email](mailto:util@fairoaksranchtx.org).
2. An application **fee of \$30.00** will be **included on the first bill**.
3. Payment is due every month for all services as billed in accordance with the rates, rules, and regulations set by City ordinance. The **Due Date Is The 25th Each Month**.
4. **Bills are mailed** by the 10th each month. Not receiving the bill does not remove the obligation to pay or the consequences of non-payment. The applicant is responsible for contacting FORU for the amount due.
5. **Backflow assemblies** are required for irrigation, pool auto-fills, and rainwater harvesting systems and must be inspected annually (septic) or every 3 years (City sewer); non-compliance may result in service disconnection.
6. **Accounts** can only be **closed** by account holders and a completed [Disconnect Request Form](#).
7. FORU **will not disclose customer information** unless the customer elects to make the information public. The [Disclosure of Information Form](#) is available at City Hall and on the [website](#).
8. **Irrigation** with hose-end sprinklers or automatic irrigation systems is allowed once a week from 12 am to 10 am, and 8 pm to 12 am on the authorized watering day; according to applicant's **street address ending in:**

Please Note: If a **rental premises** is vacated with a past due balance, the property owner (landlord) shall be responsible for the past due balance. As such, FORU reserves the right to apprise the Landlord of any past due amounts.

Please Note: Per Ordinance [13.03.011 \(j\)](#) – It shall be **unlawful** for any person, firm or other entity to damage, molest, move, connect to, disconnect from, bypass or remove, or in any other way tamper with water or sewer mains, lines, or equipment. If any damage results from any of these, or other illegal actions, the owner shall be immediately responsible financially to FORU for repair, and/or replacement to the original state. Any repair of accidental damage to these facilities will also be billed to the owner.
