THE MOUNT UNION BOROUGH POLICE DEPARTMENT MAY BE REQUESTED TO PERFORM A BACKGROUND INVESTIGATION PRIOR TO THE APPROVAL OF THIS APPLICATION AND THE ISSUANCE OF A PEDDLER'S PERMIT. THE APPLICATION HEREIN GIVES CONSENT FOR SUCH AN INVESTIGATION TO BE COMPLETED BY THE BOROUGH. UPON ISSUANCE, APPLICATION AND PERMIT COPIES SHALL BE GIVEN TO THE MOUNT UNION BOROUGH POLICE DEPARTMENT AND THE CODES ENFORCEMENT OFFICER.
