Conditions on Solicitation Permit

1. Per section 135-3 of the Jenkintown Borough Code, solicitation hours are from 10:00 a.m. to 6:00 p.m. Monday through Friday. There is no soliciting on Saturdays, Sundays, or holidays. Solicitation is limited to the days/times listed on the permit.
2. Solicitor(s) must check in at Jenkintown Borough Hall (700 Summit Ave., Jenkintown, PA) prior to beginning door-to-door solicitation on each day of the permit.
3. A copy of the permit must be kept on all solicitors at all times during solicitation.
4. Solicitation is limited to the persons stated on the permit.
5. There shall be no solicitation on properties that have been posted "No Solicitation" / "No Solicitors" per section 135-5 of the Jenkintown Borough Code.
6. There shall be no soliciting on properties that have registered on the Borough's "No Solicitation Registry" per section 135-6 of the Jenkintown Borough Code.
7. A copy of this permit has been provided to the Jenkintown Police Department.
