



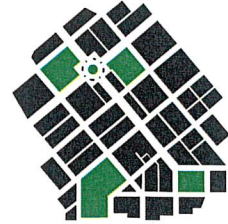

RIGHT-OF-WAY & STREET OPENING & REPAIR PERMIT INFORMATION

(Includes any work within the public right-of-way)

1. Ensure you have the proper bond with the appropriate dates and the amount that is required by the City. An individual bond amount is determined by the work that is being performed. This figure need to be determined/verified by City personnel. The fee schedule explains how this figure is determined. For a blanket bond, the bond amount must be \$20,000.00.
2. It is best to have the insurance company email a digital copy of the bond to mbailey@cityofgreenville.org for approval prior to the client picking it up. WE HIGHLY ENCOURAGE THIS!! This will save the contractor a lot of time and frustration to have all of this completed before applying for the permit.
3. The City must have the original bond on file in order to issue a permit. No permit will be issued without the proper bond on file.
4. Complete the Street Opening/Right-of-Way Permit application and remit the \$60.00 permit fee. The city accepts cash or check (made out to the City of Greenville) in the office. A link can be emailed for online payment.
5. Always call for an inspection before you pour. A 24 hour notice is required. 937-548-4930

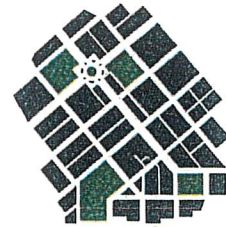
A permit and a bond are required for water / sewer taps to the City utilities.

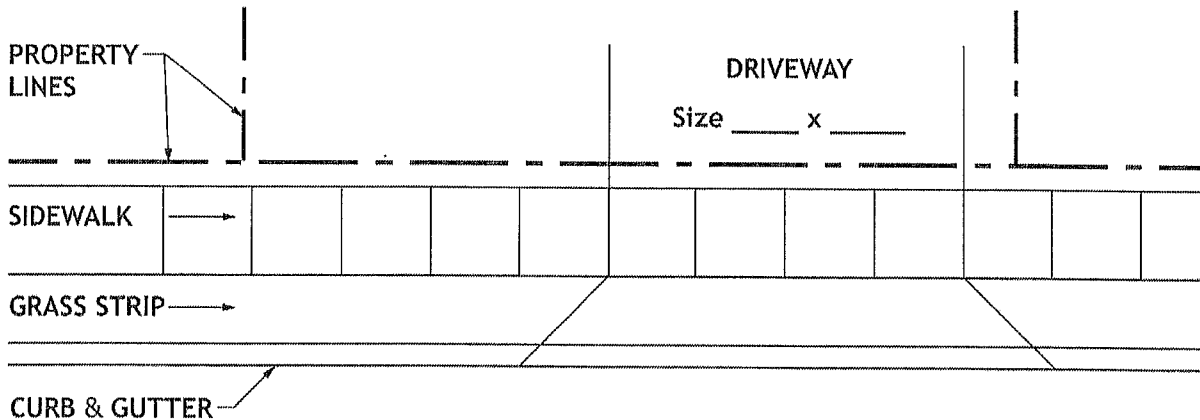
