NOTE: Landscape material of any sort is not allowed to be placed in a public roadway.

NOTE: Operators of landscape equipment are not permitted to operate/drive such equipment as a means of conveyance on Borough roadways and will be subject to Title 39 traffic offences, including: Unregistered vehicle 39:3-4, Uninsured vehicle 39:6B-2, among others.

Permit obtained after March 1st shall be \$100 and include up to five vehicles.
