Notice:

- 1] All applicants must take the Training Program developed and administered by the Trumansburg Farmers Market Organization.
- 2] All applicants must read the **Village of Trumansburg Local Law 5 of 2013**, effective October 9, 2013 and abide by its content.
- 3] You must agree to allow Zoning and Code Enforcement Officers and Chicken Liaison Person access to yard during normal business hours.

- 1] A drawing of the property showing dwelling, sheds, garages and location of chicken coop and run. Drawing must show distances from property lines and structures.
- 2] Drawing of type of chicken coop.
- 3] Materials of fencing.

Application Fee: \$40.00 for new submission and Permit is good for One (1) year and may be renewed at an Annual fee of \$25.00. **Fee and Drawing and Training Certificate must be with application.**

CONTINUED ON BACK:

I have read and will abide by the Village of Trumansburg Local Law 5 of 2013.

I am aware of the required training and requirements.

I am aware that the 1st year of the Chicken Law allows only 15 Permits and if approved by the Village Trustees in 2014 there will be 25 Chicken Permits allowed.

People with current chicken permits will have 1st opportunity to renew permits.

Other people may apply to obtain permits up to the limit of Permits allowed. If there are more applicants than number of permits allowed, this is the procedure:

1] Current Chicken Permit holders are allowed 1st chance to renew their permits.

2] People who want a permit must provide a completed application with fee and drawings.

3] After the renewals are completed, then we will go by date of properly completed Application submission up to the allowed number of permits.

4] Final decisions by Zoning and Code Enforcement Officer is final.

So it is important to make sure your application is properly completed and submitted as soon as possible.
