- That no hydrant use shall be carried out on Fridays, Saturdays, or Sundays without prior written.
- That no hydrant use shall be carried out in temperatures below 35 degrees Fahrenheit without prior approval.
- Erosion control measures must be installed as required and approved by the Village Engineer.
- Any Permit Application for Hydrant Use issued hereunder is issued pursuant to the terms and conditions contained in the above application and are accepted by the applicant upon his promise and agreement to perform all the terms and conditions set forth above.
